## **About GGS Cookies**

### **Are our cookies halal-certified?**

Yes! Our cookies are halal-certified.

**Are our cookies vegetarian-friendly?**

Yes! All our cookies are vegetarian-friendly! However, they do contain milk powder & whole egg powder.

**Do our cookies contain nuts?**

No, our cookies do not contain any nuts. However, the cookies are manufactured in a facility that also manufactures other products that contain nuts.

**When will the cookies expire?**

Our cookies have a shelf-life of 9 months after production. This is to preserve its optimum taste, texture and appearance. The cookies should be stored in a room temperature environment (below 32 °C). Expiry date of the cookies are indicated at the bottom of the cookie tins.
